The Annual Stockholders' Meeting of STI Education Systems Holdings, Inc. In its meeting held today, 11 October 2024, the Board of Directors approved the holding of the Annual Stockholders' Meeting of the Company on 18 December 2024 at 3:00 P.M. via remote communication through Microsoft Teams. Furthermore, the Corporation's stockholders of record as of 25 November 2024 shall be entitled to notice of and to vote at the Annual Stockholders' Meeting.

The Board of Directors of the Company likewise (i) approved the holding of the 2024 Annual Stockholders' Meeting of the Company through remote communication and voting in absentia and through proxy; and (ii) authorizes the stockholders to vote in the election of Directors and on other matters stated in the agenda through remote communication.
